However, the condensed version (pasoc00_cc) does not permit an unambigous translation of the SOC 2000 to the ISCO 1988. I understand I need a special license for this. However, is there a way to get the data on a more aggregated level which gurantees the anonomity of the respondents (e.g. one or two digit level)? This would be a nice addition for future data deliveries as well I believe.

In the meantime, you could download the Special License version of the data and get access to the 4-digit version of pasoc00 and transform into ISCO88 as per the guidelines who have mentioned earlier. As your request for SL data is very valid, don't envisage any problems in your application being approved quickly (of course as long as the other conditions of using such data are met).
