Does the Understanding Society cohort include a subset of participants who have given consent to be recontacted regarding participation in further research?

The context behind this is that Akrivia Health are working in partnership with Cardiff University and the National Centre for Mental Health (NCMH) on the Precision Neuroscience Research Initiative - a programme of work to establish a precision neuropsychiatry data- and bioresource (more details can be found in the attached project summary). Our goal with this resource is to accelerate research into mental health disorders and cognitive function, hopefully leading to exciting and innovative precision treatment development for dementias, bipolar, depression and psychosis.
